

TNC 09 App A TNC Life Membership Guidelines & Nomination Form

A Tauranga Netball Life Membership Award recognises an individual who has made an significant and outstanding contribution to the game of netball at Tauranga Netball Centre (TNC) in one, some or all of the following areas:

Administration
Umpiring

Coaching
Playing

Managing
Volunteering

Pre-requisite for Nomination:

- An individual must have completed a minimum of fifteen **(15)** years of service to TNC. This person is the Nominee. The length of service is not in itself a qualification.
- During this time of service, the nominee has consistently upheld the TNC values and demonstrated a positive and significant contribution to TNC.
- The nominee must already hold or meet the criteria of a TNC/Regional Service Award.

Basis for Award:

The details that were supplied for the Service Award can be summarised and included in this nomination for Life Membership. Details for this nomination should outline the continued service since the nominee received their Service Award. These details should be informative, accurate and fully detailed to ensure a full assessment of the nomination can be made. When assessing a nomination, consideration is given to:

- The level at which the contribution was made.
- The length of time over which the contribution was made.
- The quality of the contribution made.
- The impact that the contribution has made to netball, the netball community and Tauranga Netball Centre.

Procedure for Nomination:

Nominations are to be made on the official nomination form (available from the TNC Office or from the TNC website (www.co.nz), and can be made by any affiliated Member, Club/School, Life Member or Board Member. The person, club or school that provides the nomination is the Nominator.

All relevant information should be provided (including dates), as the assessment of the nomination will be based on the material supplied.

Information supplied shall consist of:

- Personal Details relating to the nominee;
- Full details for positions held and years of service;
- Disclosure of any paid service;
- A statement provided by the Nominator outlining the basis for the nomination.

Nominations are to be submitted to the **Tauranga Netball Centre Awards Committee** (TNCAC), to be received no later than 4pm on 31 **October 2022**. This nomination is to be marked “Confidential” and can be submitted as follows:

Consideration of Nomination:

All nominations are considered by the TNCAC to determine if the nomination is to be presented to the Tauranga Netball Centre Board (TNCB). The Nominator will be advised of the outcome of the decision made by the TNCAC (this decision is not subject to appeal or review).

Approval of Nomination:

The TNCB will present recommended nominations at the next The Tauranga Netball Centre Board meeting and approval will be by majority decision of TNC board.

Membership Award badge will be presented to nominees who are successful at the next AGM.

Unsuccessful Nominations:

The TNCAC gives careful and full consideration of each nomination, based on the information that is provided within the nomination form. Nominations can be re-submitted in future years and will need to include additional and/or more details to further support the nomination.
